The SN74CBT16244C is a high-speed TTL-compatible FET bus switch with low ON-state resistance (r_{on}), allowing for minimal propagation delay. Active Undershoot-Protection Circuitry on the A and B ports of the SN74CBT16244C provides protection for undershoot up to -2 V by sensing an undershoot event and ensuring that the switch remains in the proper OFF state.

The SN74CBT16244C is organized as four 4-bit bus switches with separate output-enable $(1\overline{OE}, 2\overline{OE}, 3\overline{OE}, 4\overline{OE})$ inputs. It can be used as four 4-bit bus switches, two 8-bit bus switches, or as one 16-bit bus switch. When \overline{OE} is low, the associated 4-bit bus switch is ON, and the A port is connected to the B port, allowing bidirectional data flow between ports. 


To ensure the high-impedance state during power up or power down, \overline{OE} should be tied to V_{CC} through a pullup resistor; the minimum value of the resistor is determined by the current-sinking capability of the driver.


logic diagram (positive logic)




Figure 1. Device Test Setup



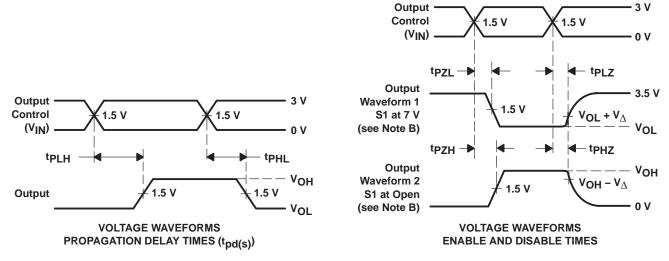


Figure 2. Transient Input Voltage (V_I) and Output Voltage (V_{OUTU}) Waveforms (Switch OFF)

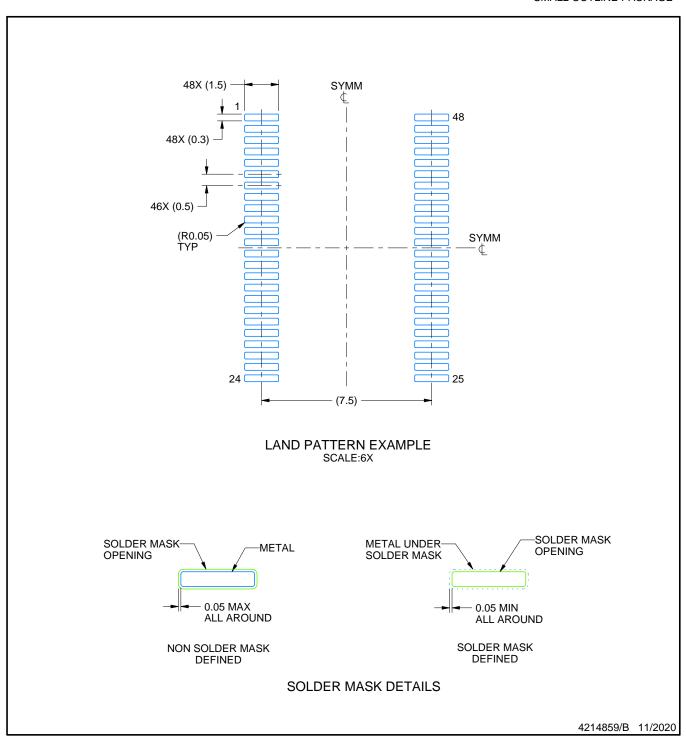

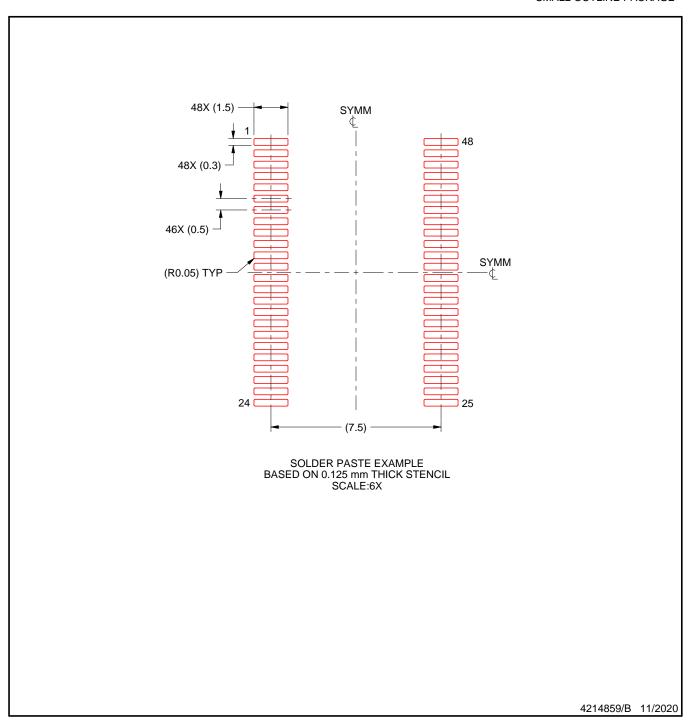
