

### **DESCRIPTION/ORDERING INFORMATION**

The SN74LVC2G34 is a dual buffer gate designed for 1.65-V to 5.5-V  $V_{CC}$  operation. The SN74LVC2G34 performs the Boolean function Y = A in positive logic.

NanoStar<sup>™</sup> and NanoFree<sup>™</sup> package technology is a major breakthrough in IC packaging concepts, using the die as the package.

This device is fully specified for partial-power-down applications using  $I_{off}$ . The  $I_{off}$  circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.






